# MINUTES OF THE 63rd ANNUAL MEETING OF THE FLORIDA ENTOMOLOGICAL SOCIETY

The 63rd Annual Meeting of the Florida Entomological Society was held in The Plaza (hotel) at Daytona Beach, Florida 27-29 August 1980.

The opening session was brought to order by President Norman C. Leppla at 1:03 PM 27 August 1980. The Invocation was by Howard V. Weems, Jr., Florida Department of Agriculture and Consumer Services (DACS), Division of Plant Industry, Gainesville. The Welcome was by the Honorable Larry Kelly, Mayor of Daytona Beach. Among the announcements was a short report by W. L. Peters on the passing of Reuben Capelouto 5 July 1980. Reuben was a pest control operator and staff member of the Department of Entomology, Florida A. & M. University in Tallahassee, where he was instrumental in developing the pest control curriculum.

N. C. Leppla delivered the Presidential Address (see elsewhere in this issue), following which came presentations of scientific papers. Seventy-seven persons attended the morning session. The "Annual Bull Session" was held from 7 to 9 PM, 27 August 1980, C. W. McCoy presiding. F. W. Mead started the "Bull Session" by showing slides taken at the 61st Annual Meeting in St. Augustine, 5-8 September 1978. W. H. Whitcomb discussed an embryonic organization known as the Southeast (U.S.) Biological Control Working Group. H. V. Weems, Jr. read all the proposed changes of the Bylaws and interspersed comments on reasons for the changes. There was discussion on the possibility of having a Florida Congress of Entomology once every few years, and ideas for promoting entomological exchanges with Latin America were presented. The "Bull Session" was followed by an industry-sponsored hospitality hour. On Thursday, 28 August, the entire morning session was devoted to an Insect Behavioral Ecology Symposium. Thursday afternoon consisted primarily of the Graduate Student Paper Contest. The Awards Dinner was held Thursday evening poolside at The Plaza. The setting was memorable with palm trees, formations of brown pelicans flying back and forth overhead, music provided by the Duke Gainous Quartet, and a full moon rising over the adjacent Atlantic Ocean. The reading of scientific papers ended at noon on Friday, the total for the whole meeting being 44 presentations. G. B. Edwards of the Division of Plant Industry, presented an Invitational Paper on "The Salticidae of Florida."

The Preliminary Business Meeting was called to order by President Leppla at 4 PM, 27 August. Approximately 60 members were present. Secretary Mead presented the minutes of the 62nd Annual Meeting as published in the *Florida Entomologist* 63(2):262-75, June 1980. L. C. Kuitert moved that the minutes be approved as presented; seconded by A. G. Selhime; motion carried.

#### REPORT OF THE MEMBERSHIP COMMITTEE

In June 1980, there were 769 subscriptions of which 482 were regular memberships (401 full, 72 student, 7 honorary, and 2 emeritus members), 18 were sustaining memberships, 234 were library memberships, and 35 were gifts or exchanges. Most of the 85 members dropped from the Society in December 1979 because of delinquent dues, were contacted by the Committee and some memberships were renewed. Reuben Capelouto. (7 November 1920-5 July 1980). Reuben owned a pest control business, and was a staff member at the Department of Entomology, Florida A & M University, Tallahassee, Florida.

Robert K. Clark, Jr. (18 March 1922-12 June 1980). Biological chemist with Abbott Laboratories, North Chicago, Illinois, and more recently working out of St. Petersburg, Florida. Obituary, this issue of Florida Entomologist.

John T. Creighton (18 August 1905-23 May 1979). Retired Chairman, Department of Entomology, University of Florida. Obituary, Florida Entomologist 63(1):196-8, March 1980.

Stuart W. Frost (4 December 1891-21 January 1980). Professor Emeritus Pennsylvania State University; part-time researcher at Archbold Biological Station, Lake Placid, Florida. Obituary, Bull. Ent. Soc. Amer. 26(2):138, June 1980.

Ellery W. Jamieson (Deceased 28 December 1979). Resided at 4011 Florida Avenue, Tampa, Florida 33603.

Herbert Spencer (7 April 1894-1980). President of the Florida Entomological Society in 1940. Formerly in charge of entomological research, research in USDA laboratories at Ft. Pierce and Orlando, Florida. Dr. Spencer replaced W. W. Yothers at these labs.

Recently deceased non-members who made significant contributions to entomology in Florida include:

Francis F. Bibby (12 February 1894-3 March 1980). He was an assistant nursery inspector and assistant entomologist with the State Plant Board of Florida 1916-1917. See Obituary Bull. Ent. Soc. Amer. 26(2):134-5, June 1980.

Nell B. Causey (8 December 1910-31 October 1979). Dr. Causey was a long-time Research Associate of the Florida State Collection of Arthropods and a world-renown taxonomic authority on Diplopoda. She was formerly an Instructor at the University of Arkansas and Associate Professor in Zoology at Louisiana State University. She developed one of the largest private collections of millipeds in the world. It has been donated to the Florida State Collection of Arthropods.

Arthur W. Lindquist (17 March 1903-11 March 1980). Former Chief, Insects Affecting Man and Animals Research Branch, Entomological Research Division, Agricultural Research Service, USDA. He was stationed at the Orlando, Florida Laboratory 1942-1946, and involved in cooperative training courses with the University of Florida in alternate years from 1963-1971. Obituary, Bull. Ent. Soc. #### REPORT OF THE AMERICAS COMMITTEE

The Americas Committee met 3 times during the year to consider ways of increasing the influence of the Florida Entomological Society in Central and South America and the Carribbean. We discussed various methods of encouraging Latin American interest and participation as members and in submitting manuscripts. Among the many options considered, was the possibility of changing the name of the Florida Entomologist. This was rejected but the Committee did recommend adding the subtitle "An International Journal for the Americas" to be placed immediately under "Florida Entomologist" on the cover. To make room for this change, the committee also recommended that "The" be dropped from the front cover. Both of these changes have been put into practice. We also have recommended that all articles published in the Florida Entomologist have a Spanish abstract in addition to the English abstract. This will be implemented as soon as willing and competent translators can be recruited.

We also recommend increasing exchanges of the *Florida Entomologist* for foreign publications. A list of New World publications dealing with entomology has been prepared and is now being checked for accuracy and completeness. The Committee recommends that 2 members be appointed to work with the Business Manager to form an Exchange and Gift Committee to arrange exchanges and to determine in which library the foreign journals should be deposited.

All entrants were given a ticket to the banquet at which the awards were announced. The winners were:




Fig. 1. Dr. Emil A. Moherek, Chairman Honors and Awards Committee (left) congratulates James E. Brogdon who has just received a plaque from Mr. Allen G. Selhime (right) of this Committee. The plaque reads as follows: "The Florida Entomological Society pays tribute to James E. Brogdon, retired, in recognition of your many years of diagnosing pest problems and prescribing cures while maintaining the utmost professional 'bedside manner.' We hereby confer to you the honorary title, "Dr. of Entomology" August 28, 1980". Photograph by Frank W. Mead.

#### REPORT OF THE LOCAL ARRANGEMENTS COMMITTEE

Summaries: Registration totaled 160 persons; 88 rooms were used at the hotel; 111 banquet tickets were sold; 107 people were actually fed.

The Chairman thanks Jonas Stewart who was in charge of the projectors, and Cheryl Crozier who assisted him and prepared the blue posters seen at the meeting.

Recommendations: (1) We need to encourage pre-registration, even if it is necessary to have a slight discount under the registration fee. The Society might consider increasing the registration fee so that the annual meeting can completely carry itself financially; (2) There is a need to devise a standard guideline for speaker coordination with the projectionists; (3) There is a need to appoint a strong Industry hospitality committee to be responsible for their hospitality hour and to coordinate it with local arrangements.

#### REPORT OF THE LONG RANGE PLANNING COMMITTEE

The Blue Ribbon Committee appointed 2 years ago by then President Bob Brooks and designated the Long Range Planning Committee by President Norm Leppla in its second year of existence, concentrated part of its energies during the second year in helping to bring to fruition some of the recommendations made the previous year. A primary recommendation had been that the Society take steps to extend its influence into and increase its appeal to Latin America. This seemed appropriate since many of the Latin American countries share entomological and agricultural problems with Florida. Furthermore the entomologists of some of these countries have expressed a need for a publication outlet which will give them greater exposure, and the Florida Entomologist could serve this need. As a step in this direction plans have been made to begin including a summary in Spanish of articles which appear in the Florida Entomologist, and an Americas Committee has been established to make an in-depth study of actions which might be taken by the Society to broaden the scope of its program in a manner which would encourage participation by Latin American entomologists. There is a general interest in tropical problems outside of the limits of the U.S., and Florida should provide that leadership.

This Committee was charged with providing recommendations for procedures which would provide for greater continuity from one administration to the next. This led to the appointment of an ad-hoc Constitution and By-

laws Committee to develop and recommend to the Society several changes in the Constitution and Bylaws. These changes would reconcile certain differences between the old Constitution and Bylaws and some of the practices and procedures of recent years. They should also substantially improve the transition from one administration to the next and provide for greater continuity.

This Committee has recommended that a greater effort be made to involve students at the several state universities and community colleges in the activities of the Society, and changes in the Constitution and Bylaws have been made toward this end, in addition to several other steps which are being made. This Committee recommends that a continuing special effort be made to find ways of getting a greater number of our Society members actively involved in carrying out the responsibilities and objectives of the Society.

This Committee has recommended that the Society promote the idea of a Florida Congress of Entomology to be held every 5 to 10 years at some central location. This congress would bring together people from the several entomologically oriented organizations within Florida, including those of the Florida Pest Control Association, the Florida Mosquito Control Association, the state universities and colleges, the Florida Entomological Society, and possibly others. Each congress would be planned by the designated representatives of these several organizations, who would select the time, place, and financial structure and plan the program. We recommend that during the next year the Florida Entomological Society take the initiative toward development of the first Florida Entomological Congress.

This Committee believes that in addition to the articles published in the *Florida Entomologist* another outlet is needed for more profound papers, basic in nature, and broad interest and international in scope. One step in this direction is the development of a series of special publications covering symposia developed by Dr. Jim Lloyd and Dr. Tom Walker. These new publications by the Society already are receiving wide acclaim.

A further recommendation toward broadening the scope of the Society's activities in a way which would further enhance its prestige and international appeal is that consideration be given to development of a new journal, possibly called *The Caribbean Entomologist*. Such a new journal would be self supporting through subscription and page charges. The broadening of the appeal of our existing journal may serve this need to a substantial degree, but further consideration should be given to the possibility of developing a second journal with somewhat different objectives.

A further recommendation is that the Society establish a *Memoirs* series, to be financed by a special revolving fund. We believe that this has great merit and should have a high priority in the considerations of the Long Range Planning Committee during the next year.

This Committee recommends the sponsorship of participation at our annual meetings of nationally and internationally known speakers from areas outside the southeastern United States. We recommend that increase funding be provided for this by the Society.

This Committee recommends that, as funds become available, this Society consider providing one or more graduate assistantships at the University of Florida, Florida A & M University, or possibly other state universities. These would be in the form of mini-grants. Also, we recommend that the Society sponsor state 4-H Club winners in their attendance at our state meeting and possibly at national meetings

Other steps which might be taken to encourage research relative to insects and related arthropods in Florida would be the development of Florida Entomological Society publication grants, Florida Entomological Society research mini-grants, and Florida Entomological research achievement awards.

This committee recommends that consideration be given to the development of a Patrons group which could substantially augment the funding of the Society's activities.

A further recommendation is that this Society invite the Southeastern Branch of the Entomological Society of America to meet in Florida concurrently with the Florida Entomological Society. This probably would involve a change in the time that we traditionally have held our annual meeting, but we recommend that this proposal be given serious consideration.

This concludes the report of the 1980 report of the Long Range Planning

Walker was in favor of routinely having our annual meetings at coastal locations in central Florida.
