#### HENRY C. WHITESELL

Henry C. Whitesell, 60, died August 5, 1967, in Clearwater, Florida. Born in Clearwater, he was a Gold Star Pioneer of Pinellas County, where his grandfather and father were early citrus growers. After attending local schools he was graduated from Oglethorpe University. He was a member of Blue Key Honorary Fraternity.

A life long boating enthusiast, he was a Charter Member of the Clearwater Yacht Club and was active in the U.S. Coast Guard Reserve. At the start of World War II he entered active service with the Coast Guard and served in the Pacific as a Lieutenant until he was retired in January, 1946.

After his return from the service, Henry became interested in Pinellas County Agriculture. especially in youth work with 4-H Clubs and Future Farmers. This lead him into citrus production work and from 1950 until his retirement, he was Production Manager for Clearwater Growers Association. During these years he became recognized state-wide as an authority on citrus production. He was a member of the Florida State Horticultural Society from 1951, until his death, serving as Vice President of the Citrus Section in 1960. He was active in the Florida Citrus Production Managers Association, serving as its President for several years. He was a Director and Vice President of Soil Science Foundation.

Survivors are his wife, Gladys N.; Largo; two sons, Nelson, Largo; Joe, Gainesville; five grandchildren; a sister, Mrs. Elizabeth W. Davies, Largo.

### JAMES M. WALTER

Dr. James M. Walter, a member of the Florida State Horticultural Society since 1947, died November 12, 1967 at Bradenton, Florida. He was 60 years of age.

Dr. Walter, a native of Harrodsburg, Ky., came to Bradenton from Morristown, N. J. 21 years ago, and was a plant pathologist at the Gulf Coast Experiment Station.

Dr. Walter held a B. S. degree from the University of Kentucky and M. S. and Ph.D. degree from the University of Minnesota. He was associated with the U.S. Department of Agriculture in the Division of Plant Industry for 14 years. In 1957 he received an award of recognition from the Florida Fruit and Vegetable Association for research activities with the development and release of the Manalucie tomato in 1953. He was author of various scientific articles in the area of agriculture, the latest being published in the Annual Review of Phytopathology, and received the 1966 Distinguished Service award from the Florida Seedsmen. In addition to a number of scientific societies. Dr. Walter was a member of Alpha Zeta, an honorary agricultural fraternity.

Dr. Walter published quite extensively in the *Proceedings* of the Society, his first article appearing in Volume 61 (1948).

Survivors include his wife, Mary L.; son, James M. Jr., Altamonte Springs; a daughter, Mrs. Robert L. Page, Monmouth, Maine; a sister, Mrs. William Ison, Burgin, Ky.; and 2 grandchildren, David N., and Douglas J. Walter, Altamonte Springs.

#### LOWELL WOODHAM

Lowell Woodham, director of the Florida Department of Agriculture's Inspection Division since 1963, died September 28, at University Hospital, Gainesville, Florida. He was 38 years old.

Mr. Woodham guided the Inspection Division in its dual role of protecting consumers against retail abuses and protecting industry against unfair competition. Also under his direction was the State Road Guard Service which performs general inspection activities relating to the movement of agricultural, horticultural, and livestock commodities.

A native of Hartford, Alabama, Mr. Woodham lived in Marianna and in Holmes County for many years. He served in the U. S. Air Force from 1946 to 1949.

Following his discharge from the Air Force, Mr. Woodham attended the University of Florida and was graduated with a Master of Science degree in 1955. He majored in agronomy, soils, and chemistry. Upon graduation, he joined the Florida Farm Bureau, served on its staff for five years, was employed by the Florida Department of Agriculture in 1960 as an administrative assistant. In 1961, he was named assistant director of the Inspection Division and assumed the directorate two years later.

A member of the Gamma Sigma Delta honorary fraternity, Mr. Woodham was immediate past president of the Southern Association of Food and Drug Officials. He was a Baptist and a member of the Florida Junior Chamber of Commerce, Young Democrats, Civitan Club, and Elks Club.

Survivors include his widow, Mrs. Laurita Harris Woodham, and three daughters, Lynn, age 14, and Linda and Lisa, age 7, all of Tallahassee; and five brothers and four sisters.

#### T. RALPH ROBINSON

T. Ralph Robinson, one of a dedicated team of government scientists who pioneered the introduction and breeding of new citrus varieties in Florida, died November 27, 1967, in the Grovemont Nursing Home in Bradenton, Florida, where he had been a patient since August 6 of this year.

Mr. Robinson was the last survivor of a team of scientists which was among the earliest of any group to experiment with cross-pollination in citrus to develop new varieties.

Included in the quartet of scientists besides Mr. Robinson were the late David Fairchild, Walter Swingle, and H. J. Webber.

Mr. Robinson, 90, was a native of Syracuse, New York, but moved to Terra Ceia, Florida, with his wife in 1924, where he set up his headquarters to continue the citrus breeding work.

In February 1964, the United States Department of Agriculture named an early maturing citrus hybrid (a cross between the Orlando tangelo and the Clementine tangerine) for Mr. Robinson. Since then, thousands of acres of the 'Robinson' tangerine have been planted by Florida citrus growers.

Mr. Robinson was an 1899 graduate of Syracuse University and went to work for the USDA in 1901. Here he became involved in plant physiology investigations until early 1910, at which time he became engaged as manager of citrus grove properties. In 1917, he returned to

work with breeding, selecting and commercializing the introduction of improved varieties of citrus and other subtropical fruits.

Although he had a long and illustrious career as a plant breeder and subtropical horticulturist, his most outstanding contribution to Florida Horticulture was the part he played in the development of Florida's tangelo industry.

Mr. Robinson formally retired in 1940, but even after that time he continued his work by collaborating with the United States Department of Agriculture.

Mr. Robinson was a member of the American Association for the Advancement of Science, the American Society for Horticultural Science, the Botanical Society of Washington, D. C., and Delta Kappa Epsilon Fraternity. He was also past president of the Florida State Horticultural Society and ex-director-at-large of the Florida Historical Society.

His name is listed with his biography in "American Men of Science" and also in "Who's Who." His biography also included about 80 titles of papers chiefly devoted to horticultural subjects.

Survivors include one niece, Mrs. Hazel C. Stroud of Terra Ceia, and two nephews, Richard D. Robinson of Skaneateles, New York, and Graham L. Guy of Rhodesia, South Africa.

#### ALBERT NELSON BROOKS

Dr. Albert Nelson Brooks, developer of the famous "Florida 90" strawberry died November 19, 1966.

Dr. Brooks was a native of College Hill, Ohio, and attended secondary schools in that state. Prior to receiving a Doctor of Philosophy degree from the University of Wisconsin in 1925, he had also attended the University of Cincinnati and Ohio State University. He was a Phi Beta Kappa and belonged to Sigma Xi and Gamma Alpha.


Dr. Brooks served in the U. S. Navy during World War I (1918-1919).

He was Plant Pathologist in Charge of the Strawberry Investigations Laboratory at Plant City, and had been with the Florida Agricultural Experiment Station since 1927. He was previously an instructor in Botany at the University of Cincinnati in 1922 and 1923, and Assistant Pathologist with the old Florida State Plant Board until 1927.

Dr. Brooks modestly took little credit for the part he played in putting East Hillsborough "on the map," yet it is through his 27 years of research that bigger and redder strawberries appear each year on millions of dining tables throughout the nation. Breeding strawberries for resistance to prevalent diseases had been one of his most active projects.

The "Florida 90" strawberry, so named because it once was just a number in the station's book of hybrids, was developed in 1948 from a Missionary seed parent and an unknown pollen parent. Dr. Brooks explained that it was open pollinated from other experimental plants.

## AUGUST BURRICHTER



Agriculture lost an eminent friend when August Burrichter died at Homestead, Florida, August 17, 1967, at age 75.

August was born January 9, 1892, at Ledde, Westfalia, in Germany. He grew up on the family farm, entering the Gymnasium at Osnabruek (the humanistic secondary school) at age 12. At 19 he was employed by a Hamburg trading house and was later sent to its London branch. In World War I he was commissioned a Lieutenant in the German cavalry on the Eastern Front. In the latter part of the war, he serve with units in France.

Following the Armistice, August entered the Agricultural University (Landwirtschaftliche Hochschule, Berlin). After his graduation, with a small group of associates he emigrated to Mexico in 1922, settling near Mexico City, and operated a large dairy farm until the middle Twenties. In 1926 he and his brother Willie moved to Clewiston. Their first crop of peppers and squash was a disaster first with floods and then frost. Salvaging what they could, they moved south to Homestead where they farmed on rented land on the East Glade. During summers from 1927 to 1934, he worked with the Ferry-Morse Seed Company as a plant breeder, making significant contributions to pepper and squash lines. He acquired land in Homestead and gathered a faithful crew of workers, most of whom remained in his employ throughout the years of growth and success of the farm.

As a commercial farmer, he was primarily interested in pole beans and potatoes, but throughout his life the farm was the hub of a great amount of experimental plant breeding and disease work by major seed companies and universities.

In 1940, August married. He and Osa had four fine children: Walter, August, Minna, and Metta.

August's great capabilities and realistic imagination were appreciated by all who knew him well. To those who addressed him as a "grower," he lifted a scolding finger, preferring to be known as a "farmer." August was a farmer in the simple and glorious meaning of the word, a very good farmer.

#### REPORT OF FLORIDA AGRICULTURAL COUNCIL

The Annual Meeting of the Florida Agricultural Council was held in Orlando, Florida on December 2, 1966 at the Florida Fruit and Vegetable Association offices. During this meeting the following officers were elected to serve for the year 1967:

Directors: Francis Branon, Ed Finlayson, John Henry Logan, Ed Price, Dick Minton and Art Higbie It was decided at the Annual Meeting to request of the FNGA that their executive secretary, Jim Griffin, be allowed to represent the Florida Agricultural Council during the forthcoming session of the State Legislature. Following this, approval was received from the FNGA president to allow Jim Griffin to represent the Council in Tallahassee. If I may digress just a minute whenever any of your meet a may digress just a minute, whenever any of you meet a FNGA member, shake his hand and thank him for allowing Jim Griffin to represent us in Tallahassee, for Jim did his usual outstanding job during the Session.

Chester Blakemore of the Florida Department of Agri-

Chester Blakemore of the Florida Department of Agriculture outlined the Department's budget and program to be presented to the 1967 session of the Florida legislature. It was agreed by all present that the Florida Agricultural Council would support and work to see that the Department's budget was approved as presented.

The budget for the Institute of Food and Agricultural Sciences was explained in great detail by Dr. York and members of their staff. Even though we had a Republican Governor for the first time since reconstruction days, and an urban-oriented legislature, we felt that the modest budget request of the Institute of Food and Agricultural Sciences an urban-oriented legislature, we felt that the modest budget request of the Institute of Food and Agricultural Sciences, which had been approved by the University and subsequently by the Board of Regents, would be approved by the Budget Commission; for it was certainly a very minimum requirement in relation to what is actually needed; not only to correct some salary inequities within the university system, but also to make Florida competitive with the other leading agricultural states. the other leading agricultural states.

The Budget Director, following Governor Kirk's directive, cut the 30.5 million budget to 23.2, or a decrease of 6.7 million dollars. Of course, this applied to general revenue fund only. This is the budget which had been approved both by the University and the Board of Regents. Following this, the budget was approved by the Budget Commission. After Governor Kirk's budget message we realized that we had a beauty hill fact the budget was approved. that we had a hard up-hill fight on our hands to get appro-

val of the Institute's budget.

During the session of the legislature Jim Griffin, the officers and members of the Council spent many hours contacting the various legislators trying to get the budget cuts restored. After all the facts had been presented to the members of the Cabinet and they had given careful consideration to the problem, six of the seven members of the Florida Cabinet asked the legislators to restore the cuts which they, acting as the Budget Commission, had originally made.

Three times during the session of the legislature bills were introduced to increase the Institute's budget by 1.7 million dollars, and all three times these bills were vetoed by action of Governor Kirk. In addition, a bill for 219,000 dollars was approved by the legislature to provide personnel and operating funds for the new research facilities at Apopka and Marianna. This bill was also vetoed by Governor Kirk. It is very probable that due to lack of funds, the new facilities at both Apopka and Marianna will stand idle.

During the past several years the salaries of Florida Agricultural scientists have slipped from a ranking of 14th to 38th. Just think about that. Also, Florida ranks 24th among the 50 states in support of agricultural extension programs. During this same period, the enrollment in the College of Agriculture in the last three years has been increasing at a rate of two to two and one-half times as fast as the rest of the University.

Agri-business is Florida's number one industry, and the largest single source of revenue to the State. Florida ranks fargest single source or revenue to the State. Florida ranks fifth in the nation in cash income from the sale of crops, and at the very least we should rank fifth in the nation in our support of Agricultural research and education. There is no state in the country, except perhaps California, which has the great diversity of agricultural and environmental conditions which prevail in Florida.

Gentlemen, let me say that the situation we face today is the progressive.

is very serious. When you consider the increase in taxes.

operating cost and foreign competition, it is a fact that the operating cost and foreign competition, it is a fact that the only way we can continue to exist and produce food is by investing in agricultural research and education for the future. Let me add that the general public has a great stake in this matter, because the consumer has been the principal beneficiary of agricultural research programs. You are professional farmers, but faming in everyone's business. The Florida Agricultural Council will not rest, or slacken its efforts, until Florida is number one in the nation in its support of agricultural research and education. in its support of agricultural research and education.

This fund was sponsored by the Florida Agricultural Council with a contribution goal of \$8,000.00. Federal legislation had been enacted that would provide \$11.50 in federal money for each dollar of contributed money obtained, providing that these funds were used to create a student lean fund. This fund was established in the College funds. loan fund. This fund was established in the College of Agriculture in the University of Florida and provides loans that are essentially interest free to the student until he graduates from college.
  - That the 1967 Executive Committee recommend to the membership at the next annual meeting that the by-laws be changed to screen resolutions through the Sectional business meeting, the Resolu-tions Committee, the Executive Committee, and the annual business meeting. A proposed draft of the by-law revision was prepared for presentation to the annual business meeting, on November 8, 1967. The disposition of this recommendation will be carried in the minutes of this annual business meeting.

# At the meeting of May 10, 1967, at Lake Alfred: The following motions were adopted:

That a special copy of the 1966 Proceedings be bound for presentation to Mrs. Frank L. Holland, together with a letter expressing the appreciation of the Society for Frank L. Holland's long period

# 80TH ANNUAL BUSINESS MEETING November 8, 1967 Miami Beach, Florida

The meeting was called to order by President Ed H.

Price, Jr., at 11:00 a.m.

The minutes of the 79th Annual Business Meeting, held in Miami Beach on October 26, 1966, were approved as printed on Page 513 of Volume 79 of the Proceedings, upon order of the President.

The report of the Executive Committee for 1967, presented by Secretary Herman J. Reitz, was approved as read. This report is printed elsewhere in these Proceedings.

Special recognition of 1967 Sectional Vice-Presidents for their invaluable service to the Society was given by President Price in the form of presentation of gavels especially engraved with their names and offices.

Old Business: There was no old business.

New Business:

Secretary Reitz presented to the membership two proposals for revision of the Constitution and By-Laws of the Society. Both of these proposals had had previous endorsement of the Executive Committee. A proposal for the

orderly handling of resolutions is as follows:

"Resolutions may originate either in the Resolutions Committee or in a regularly scheduled sectional business meeting. In the latter case, the resolutions must be supported by a majority vote of those members present and voting. All resolutions will be evaluated by the Resolutions Committee and transmitted with its recommendation to the Chairman of the Executive Committee. He will place them before the full Executive Committee. by either (a) calling a special meeting of the Executive Committee or (b) instructing the Secretary to poll the members of the Executive Committee. Those resolutions approved by at least eight members of the Executive Committee will be presented by the Chairman of the Resolutions Committee to the membership at the annual form of the property by the Society as a whole." business meeting for action by the Society as a whole."

Reitz moved the adoption of the proposed revision. R. S. Edsall seconded the motion, and it carried.

WHEREAS, The 1962 freeze gave impetus to the rapid expansion of the Florida citrus industry and led to the heedless propagation of many thousands of citrus trees from unregistered and unknown parentage; and,

WHEREAS, Indiscriminate selection of scion budwood and rootstock seed sources has resulted in an alarming increase in the utilization of virus infected plants, probable use of off-type clones that could result in many poor quality non-productive trees; and,

WHEREAS. The recent downward trend in citrus prices has caused many non-registered citrus trees to be offered for sale on a "just as good as registered" basis; and,

WHEREAS, It has been the objective of the Florida State Horticultural Society to foster the improvement of the state's citrus budwood registration program; and,

WHEREAS, The value of this program has been demonstrated forcefully by a general decrease in the incidence of virus diseases by excellent yields of high quality fruit through carefully selected bud sources;

NOW THEREFORE BE IT RESOLVED: That the Florida State Horticultural Society reaffirms its sponsorship of the Citrus Budwood Registration Program, with the registered citrus tree declared as the minimum quality tree recommended for planting in Florida citrus groves, and

BE IT FURTHER RESOLVED: That established research agencies be requested to intensify research efforts into the comparative merits of various registered stocks and scions and that the Agricultural Extension Service and other educational agencies be requested to implement educational programs which will foster the use of registered trace only and trees only, and

BE IT FURTHER RESOLVED: That the Society reaffirms its belief in the registration program by mailing
