## 58th Meeting of the Coastal Engineering Research Board (15-17 June 1993)

The 58th meeting of the Coastal Engineering Research Board (CERB) was held on 15–17 June 1993, in Atlantic City, New Jersey. The CERB is congressionally mandated to advise the Chief of Engineers on all matters related to coastal engineering. The Board meets twice a year in different geographical areas to obtain a better understanding of problems in the areas.

The Board is comprised of seven members. The President of the Board is BG(P) Stanley G. Genega, Director of Civil Works. The other three

military members are BG Roger F. Yankoupe, Commander, South Atlantic Division; BG Paul Y. Chinen, Commander, North Atlantic Division; and BG Ralph V. Locurcio, Commander, Pacific Ocean Division. The three civilian members are Dr. Robert A. Dalrymple, University of Delaware; Dr. Fredric Raichlen, California Institute of Technology; and Dr. Paul D. Komar, Oregon State University. The Commander of the U.S. Army Engineer Waterways Experiment Station, acts as the Executive Secretary of the CERB and is re-

sponsible for all administrative functions of the Board.

The theme of this meeting was "Coastal Data Collection." Speakers from the Philadelphia, Baltimore, Wilmington, and New York Districts, as well as from South Pacific Division and the U.S. Army Engineer Waterways Experiment Station's (WES) Coastal Engineering Research Center (CERC), made presentations pertaining to data needs and efforts in research and development, Coastal Field Data Collection Program and Monitoring Completed Coastal Projects Program, Field Research Facility activities, site-specific data collection, and new data collection technology. Guest participants included Mr. James F. Hall, the New Jersey Department of Environmental Protection and Energy; Mr. Robert Henry substituting for Mr. John A. Hughes, Delaware Department of Natural Resources and Environmental Control; and Mr. Kenneth J. Smith, the New Jersey Shore and Beach Preservation Association. In addition, a CERC presentation was made concerning the status of the sea turtle study; a representative from the Alaska District presented the Corps' involvement in St. Paul and St. George Harbors, Alaska; a report on shoreline protection was given by a representative from Headquarters, U.S. Army Corps of Engineers; and a joint report on the Chief's Charge was made by representatives from WES.

Dinner guest speaker was Mr. Thomas Gagliano, President, Jersey Shore Partnership. Dr. Andrea Lippi from Cape May County Oceanographic Institute also provided the Board and participants with his thoughts and an original poem.

On a half day field trip, the Board was able to see firsthand from helicopters, projects relating to the theme which included Barnegat Inlet; Cape May, New Jersey; Ocean City, New Jersey; and Indian River Inlet in Delaware.
