

## INFORMATION FOR CONTRIBUTORS

The *Journal of Nematology* (JON) is the official publication of the Society of Nematologists (SON) and publishes peer-reviewed original papers on all aspects of basic, applied, descriptive, theoretical or experimental nematology. JON also publishes invited reviews, abstracts of papers presented at annual meetings, and special publications, as appropriate. Authors are encouraged to consult the Editor-in-Chief (EiC) about submissions of special publications. JON is published quarterly. By submitting a manuscript to JON, the authors attest that the manuscript has not been submitted elsewhere and (if accepted) will not be published in whole or in part elsewhere without consent of the JON Editorial Board (see inside front cover). They also attest that all work contained is original. Research results submitted for publication should be reproducible. It is expected that critical experiments have been repeated in time or space and statistically validated, as appropriate. Routine surveys, for example of nematode distribution or of germplasm collections for susceptibility to parasitic nematodes, are not acceptable unless they explicitly test or generate hypotheses. Manuscripts that do not follow JON style and format procedures will be returned to the author(s) without further review. Because the Style Guide is updated regularly, authors should consult this site before and during preparation of each manuscript for JON. The current guide at the web site supersedes any previously published or electronic instructions.

Manuscripts must be submitted to the EiC. Authors are strongly encouraged to submit manuscripts electronically as e-mail attachments. Manuscripts must be Word (.doc), Rich Text Format (.rtf) or ASCII text files (.txt). Do not embed figures in the body of the manuscript text. All figures (line art, photos, and micrographs) must be submitted as separate files (identified by first author's name and figure number). For review purposes, any common file type (e.g., Power Point, Word, PDF) is acceptable. However, versions for the printer must be in TIFF (.tif), JPEG (.jpg) or Encapsulated Postscript (.eps) format.

**Manuscripts:** In preparing a manuscript for JON, authors should endeavor to express their ideas in clearly written English with US spelling conventions. There are no page limitations, but page charges (currently \$80/page) are levied. A typical paper is composed of: a title page; abstract and keywords page; an introduction; materials and methods; results; discussion; literature cited; and supporting tables and figures. For short papers, results and discussion may be combined. Style conventions established by JON for terminology, abbreviations and units of measure should be followed ([http://www.pnng.org/jon\\_style/](http://www.pnng.org/jon_style/)).

Abstracts of papers presented at the Annual Meeting of SON are published by JON. Only those abstracts submitted through the meeting web site will be accepted. Authors must follow the style guidelines and time deadlines established by the meeting organizers. Other formats are permissible for commissioned articles. Authors should discuss this with the EiC.

**Page Layout:** All submissions should be formatted on US letter or A4 paper, with 1-inch (2.5 cm) margins. Double

space all manuscript contents, except the contact (corresponding) author's name, address, phone number, fax number, and e-mail address; these should appear on the upper left-hand corner of the title page (single spaced). Pages should be continuously line numbered throughout. Choose a font that is easily read; the font size should be 12 pt. Do not use hyphenation for spacing or layout purposes.

**Figures:** Authors are required to use good ethical judgment in the preparation of figures, particularly digital figures. Images must not be cropped or otherwise manipulated to obscure, move or introduce any element germane to interpretation of the data. Although certain manipulations are acceptable, such as adjusting the brightness or color balance of an entire image, nothing should be done to any part of an illustration that does not affect all other parts equally. Exceptions to this policy (such as introducing false color to highlight a feature) are permitted only if the full consequences of that manipulation are explicitly described. **Literature Cited:** Authors have an ethical responsibility to fairly and correctly attribute previous work by citation. In most cases, it is preferable to cite the primary literature instead of a review. Authors should make every effort to cite only articles that are readily available and are particularly encouraged to cite work published in JON. In the body of the manuscript, publications are cited using the name-year system. To cite a publication with two authors, list both; with three or more authors use "et al." When multiple citations are listed in parentheses, they are listed in chronological order from oldest to most recent and separated by semicolons. If two or more cited papers are from the same year, list the papers from that year alphabetically by author. Use letters for two or more articles by the same author(s) in the same year. **Copyright and Permissions:** All material published by SON, except for papers prepared by US and Canadian government employees, is copyrighted and protected under US copyright law. Under the Copyright Act of 1976, the term of copyright for materials registered by an organization is 75 years from the date first published. Before publishing any manuscript, SON requires that authors transfer full and complete ownership of any copyright to SON by signing a copyright form. SON then registers the copyright. Subsequent use of published materials requires written permission from SON and may be obtained by contacting the EiC and stating where and how the material will be used.

The author warrants that the article is an original work not published elsewhere in whole or in part, except in abstract form and that the author has full power to make this grant. If portions of the article have been published previously, then the author warrants that permission has been obtained from the copyright holder and a copy of the permission release will be submitted with this copyright transfer form.

SON shall claim no proprietary right other than copyright. Authors and coauthors retain the right to revise, adapt, modify, or otherwise use all or part of the article in future works of the author(s), such as press releases, lectures, and reviews, provided that all such use is for the personal, non-commercial benefit of the author(s). All patent rights are retained by the author(s). Authors are free to distribute electronic and printed reprints of their articles so long as those documents were sanctioned by the EiC and are not modified from the original.
